



Additional Travel Information for Examinees Traveling to the United States

Travel Status

Examinees are responsible for making the necessary travel and accommodation arrangements. If you are neither a citizen nor lawful permanent resident of the United States, you are responsible for obtaining required travel documents. These documents may include a visa to enter the United States. The requirements of the U.S. Department of Homeland Security (DHS) and U.S. embassies and consulates regarding issuance of visas and travel to and from the United States are subject to change. You should review current requirements before applying for a visa. If you are traveling from a distant location, you should consider arriving a day or two prior to taking your exam in order to be rested for it.

Time Zone

Houston is in the Central time zone of the United States.

Currency Exchange

Currency exchanges are located in Terminals C and D of Bush Intercontinental Airport and in Hobby Airport.

Tipping

It is recommended to tip waitresses, waiters, and other service personnel a minimum of 15 percent.

Metric Conversion

One mile is equal to 1.6 kilometers.
